The Tenant Watch Archives (referred to as Tenant Watch) are made available to subscribers based on the following terms and conditions:

1. Service is supplied solely to the subscriber for single access at any given time.
2. Access is via login with Account Number and Password provided by the Tenant Watch Staff. Subscribers sharing their login information with other persons whether related or not related will be subject to immediate suspension and forfeiture of any fees paid through the end of the calendar year involved. This will be at the sole discretion of the Tenant Watch staff based on traceable information.
3. While the information contained herein is not privileged or private information we believe that it should be solely as another means for individual subscribers to check the references of prospective Tenants associated with residential rental units.
4. Each Subscriber is paying for access to the Tenant Watch Archives and any attempts to reproduce, copy or disseminate this information to others for any reason, with or without compensation, will result in the immediate suspension and forfeiture of any fees paid through the end of the calendar year involved.
5. The information provided is based on information as supplied by the District Court System of Maryland and Tenant Watch is NOT responsible for the content of this information or its accuracy. The Tenant Watch Staff will take every measure possible to insure the information is accurately fed into the system but the old adage “garbage in – garbage out” applies.
6. The subscriber acknowledges that the presence or absence of a prospective Tenant from the Tenant Watch Archives may not indicate that the Tenant may be a good or bad risk. The Tenant Watch Archives are to be considered one part of the process in verifying the credentials and creditworthiness of the prospective Tenant.
7. The subscriber agrees that it is difficult if not impossible to deliver a quality service, such as the Tenant Watch Archives, if payment for services is not received in a timely manner. With this in mind the parties understand and agree that all fees for this service are due and payable in December of each Calendar year after initial sign up and account suspension will occur the following January no sooner than the 10th of the month. It is the Subscribers responsibility to see that payment is forwarded on time. Late notices will not be mailed or emailed.
8. All notices to the Subscriber will be handled via e-mail and all inquires to the Tenant Watch Staff should also be handled the same way. Subscribers can also reach us by calling 301-777-2692 ext 115 and ask for the Tenant Watch Staff during regular business hours or in person at TWR Communications 549 N. Centre Street Cumberland, MD 21502.
9. ALOC members will have their annual Tenant Watch bill mailed to them each December along with their annual dues Invoices. Non-members will have their bills mailed directly with an invitation to join ALOC. There will be no mailing of late notices or other correspondence other than the original renewal invoice each December.
10. The Subscriber agrees and understands that Tenant Watch assumes no responsibility for the information residing in the database. The Subscribers owns and operates his/her own rental business and as such possesses the knowledge and ability to manage their own business using the information contained in the Tenant Watch Archives to make their own decisions about what Tenants to accept or reject.
